

HOW MYSSA™ CAN SUPPORT YOUR SHOOTING ORGANIZATION

We encourage your organization to host its own fund raising activity. For ONE fund raising event for your MidwayUSA Foundation endowment, MYSSA will provide additional support as described below.

The maximum amount MYSSA will match from your organization will be \$2,000.

After your fund raising activity, send your check (up to \$2,000) to MYSSA and we will add matching funding to your endowment. In turn, we will forward the total amount to the MidwayUSA Foundation where your <u>original</u> fund raising will be matched 2:1 by the Foundation plus the MYSSA contribution.

If your endowment account balance was less than \$50,000 at the end of 2016, MYSSA will match your fund raising 5:1. If your endowment account balance was more than \$50,000 at the end of 2016, MYSSA will match your fund raising 2:1.

For example, if your fund raising totals \$2000, (and your balance is under \$50,000 in your account), MYSSA will match 5:1 (\$10,000). We in turn send the \$12,000 to the MidwayUSA Foundation. Your original \$2000 is matched 2:1 by the Foundation plus MYSSA's \$10,000 earning your organization a total of \$16,000 for your endowment from a \$2,000 fund raising activity.

For example, if your fund raising totals \$2000, (and your balance is over \$50,000 in your account), MYSSA will match 2:1 (\$4,000). We in turn send the \$6,000 to the MidwayUSA Foundation. Your original \$2000 is matched 2:1 by the Foundation plus MYSSA's \$4,000 earning your organization a total of \$10,000 for your endowment from a \$2,000 fund raising activity.

MYSSA will support one fund raising event for your organization this year, however this cannot be split into separate contributions.

MYSSA will fund these events until we distribute all our available funding, or August 31, 2017 whichever comes first.

To receive MYSSA support now:

Send your check payable to MYSSA and the required information form (reverse) to the address listed.

Any organization may send their fund raising directly to the MidwayUSA Foundation and receive the 2:1 matching funds, but will not receive any additional support from MYSSA.
